Grenada, Saint Lucia and Saint Vincent and the Grenadines have received financing in the amount of:

Grenada – US 6,000,000
Saint Lucia – US 15,000,000
Saint Vincent and The Grenadines – US 5,000,000

equivalent from the World Bank toward the cost of the OECS Regional Tourism Competitiveness Project, and it intends to apply part of the proceeds to payments for goods, works, related services and consulting services to be procured under this project.

The project will include the following components

- a) Facilitation of the Movement of People through the establishment of a single regional space for immigration and customs regulations for international tourists and the development of a pilot regional ferry system corridor;
- b) Pilot tourism infrastructural investments at selected sites such as (i) the rehabilitation of Fort George in Grenada, (ii) reinforcement of marine-based tourism and rehabilitation of Fort Charlotte in SVG, and (iii) enhancement and beautification of strategic sites and attractions, improved logistics, and development of a tour for Castries in Saint Lucia;
- c) Market development and promotion capacity building that would support the refinement and operationalization of tourism plans and to develop a regional market development effort to position the countries as a one travel destination;
- d) Project management support.

Procurement activities for international competitive bidding (ICB) to include:

- i. IT Support to implement a system of unique identifier; implementing a single window for construction permits; implementing a modern property registry and the linking of the relevant registries including maintenance;
- ii. Hardware and Software for Ferry scheduling;
- iii. Goods for IT support (website, social media) presence;
- iv. Goods for the development and implementation of a regional digital/social e-tourism communication strategy and IT platform that would drive the region's travel marketing;
- v. Infrastructural Development of Fort George, Grenada;
- vi. Feasibility, rehabilitation and structural Studies, Design and supervision for the Rehabilitation of Fort George
- vii. Technical assistance to support the implementation of Regional Integration Policies;
- viii. Technical assistance to support preparing, refining, and/or deepening sustainable tourism development plans and policies, and their implementation within the Ministries of Tourism and Tourism Authorities;
- ix. Study for the preparation of a Framework Plan for down town Castries
