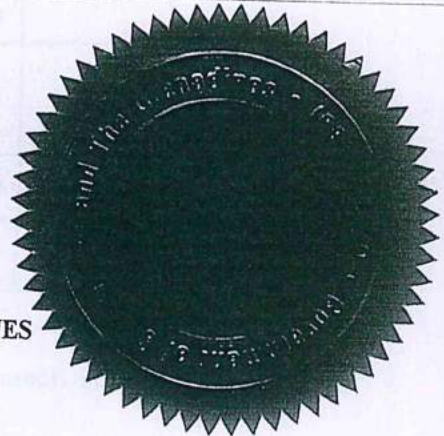

AN ACT to sanction payments from the Consolidated Fund upon certain services in excess of the Appropriation Act relating to the year ending on the thirty-first day of December, Two thousand and nineteen.

[19th October, 2021]

WHEREAS the sums of money granted by the Appropriation Act 2019 in relation to the year ending on the thirty-first day of December, Two thousand and nineteen were insufficient to meet the demands of certain services and the amounts specified in the Schedule to this Act were spent in excess of the sums granted and therefore need to be sanctioned:

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the House of Assembly of Saint Vincent and the Grenadines and by the authority of the same, as follows:

1. This Act may be cited as the Supplementary Appropriation (No. 3) Act, 2021.


2. The amounts specified in the Schedule to this Act totalling eleven million, eight hundred and forty-nine thousand, two hundred and ninety-six dollars paid and issued out of the Consolidated Fund in excess of the amounts authorised by the Appropriation Act 2019 in relation to the year ending on the thirty-first day of December, Two thousand and nineteen are hereby deemed to have been granted and lawfully appropriated for the services set out therein and are declared to have been expended on those services.
